Product Type:	Pure Extract of Brazilian Bee Propolis Flavonoids (Bee Glue) obtained by a patented water based extraction method.
Monograph	Internal, modified to DAB 10.
Origin	Manufactured in the United States of America using premium raw Brazilian Green Bee Propolis (type Ultra-Green). Raw bee propolis is a resinous substance collected by honeybees (<i>apis mellifera</i> L.) for use in the hive from different trees (botanical origin) but mainly from a local plant called “alecrim do campo” (<i>Baccharis dracunculifolia</i>).
Description and	FLAV G is a dark green free flowing powder with a characteristic aromatic smell strong taste of propolis. FLAV has been purified (free of wax and other impurities), and contains all the flavonoids from the resins and balsams in propolis.

Content	FLAV G contains not less than 5% flavonoids (50 mg/g), calculated as the total of <i>quercetin</i> , <i>kaempferol</i> , <i>chrysin</i> , <i>tecto-chrysin</i> , <i>pinocimbrin</i> , <i>galangin</i> a.o.
Identity	HPLC fingerprint-chromatogram in accordance to standard solution.
Assay	Total Flavonoids: not less than 50mg/g (HPLC).
Pharmacology effect	FLAV G has the following properties (tested in vitro and in vivo): anti bacterial on upper respiratory tract infections, anti viral effect on influenza Type A, anti inflammation, anti oxidation, immuno-stimulation, dental pulp complaints - and is used in food supplements, natural medicines, cosmetics, foods, a.o. in a concentration of approximately 25 to 150 mg (flavonoids).
Toxicology	People with known allergies to bee products should use with caution. LD-50:5000mg/Kg
Storage	Keep container well closed, protected from light and heat
Expiration	3 years stored by temperature not exceeding 20° C (68° F)
